2017 - 2018 New Student Application

ALL NEW to Indian Community School students for the 2017 - 2018 School Year will require the following documentation to be submitted with their application materials:

1. Most Recent Immunization Record
2. An Original Birth Certificate

3. Tribal enrollment information:

Proof of eligibility by virtue of tribal enrollment or descendency must be by documents issued on the letterhead of a federally recognized tribal government, or a tribal identification card issued by such tribal government.

Eligibility criteria:

- Enrolled member of a federally recognized tribe, or
- Descendant of an enrolled member(s) of a federally recognized tribe, or
- Descendant of any Native American Indian who was subject to governmentally sanctioned educational policies treating Native Americans differently than others based on their status as Native American Indians. Proof of eligibility by descendency of ancestors subject to governmentally sanctioned educational policies must be by documentary proof satisfactory to the ICS Principal.

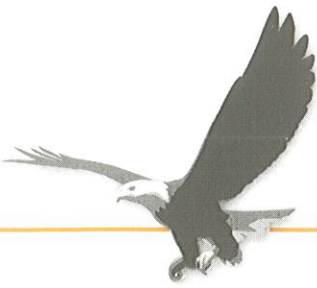
4. A most recent report card (with attendance information, teacher comments and, if applicable, a copy of any Individualized Education Plans (IEP)
5. A most recent copy of your child's MAP scores (and any other assessment scores you may have)
6. Completed ICS Student Information Sheet/Emergency Contact Form
7. Completed New Student Information Sheet
8. Completed 2017 - 2018 Request for Bus Stop Location Form

For K4/K5 Applicants Only: Completed Parent/Guardian Questionnaire* (An ASQ Parent questionnaire will be mailed separately. This questionnaire is to be completed and returned on or before the screening in May).

Please note:

Complete applications will only be accepted. A complete application includes all the information listed above; which includes all the completed forms and listed documents. No partial applications will be accepted. Completed applications can only be submitted to the school office between 7:00am – 2:30pm.

Submitting a completed application DOES NOT guarantee your child's/children's enrollment at Indian Community School. You will be notified if your child's/children's application has been accepted/not accepted for enrollment after it is reviewed.

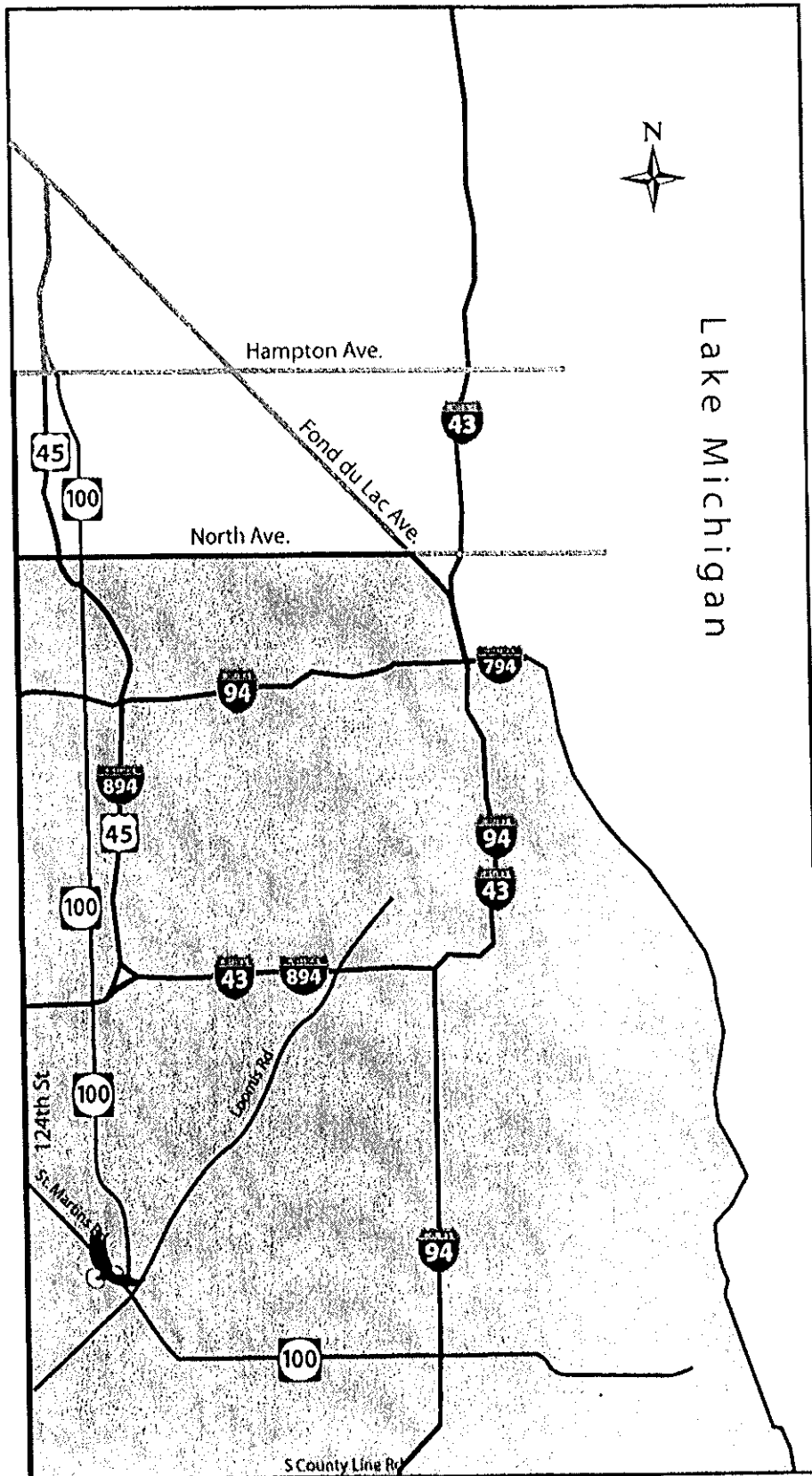

Areas in Milwaukee County:

- East of 124th Street.
- South of North Avenue.
- Southwest of where Fond du Lac Ave. intersects with North Ave. and I-43. (excluding the area east of Fond du Lac Ave., East of I-43, and north of I-794.)
- West of I-43 where it runs north of its intersection with I-794.
- South of I-794 between its intersection with I-43 to both the west and Lake Michigan to the east.
