This is an example of a typical daily schedule for the Y School Age Program:

- 8 – 8:20 a.m. Clean up and Social Time

### Afternoon Program:

- End Bell Arrival/Attendance/Bathroom
- 3:30 – 4 p.m. Healthy Snack and Social Time
- 4 – 4:40 p.m. Homework Help
- 4:40 – 5:30 p.m. Physical Fitness Activity
- 5:30 – 6 p.m. Clean up and Free Choice Activities

## » PROGRAM RATES

Rates are based on 180 days of school to calculate a flat monthly fee equating to nine equal payments from September to May. Credits will not be given for non-attendance or for days when the school district chooses to close, such as inclement weather.

All fees must be paid monthly. Families will receive a 10 percent discount for each additional child registered.

**Confirmation:** Once your child is registered, you will receive a confirmation email.

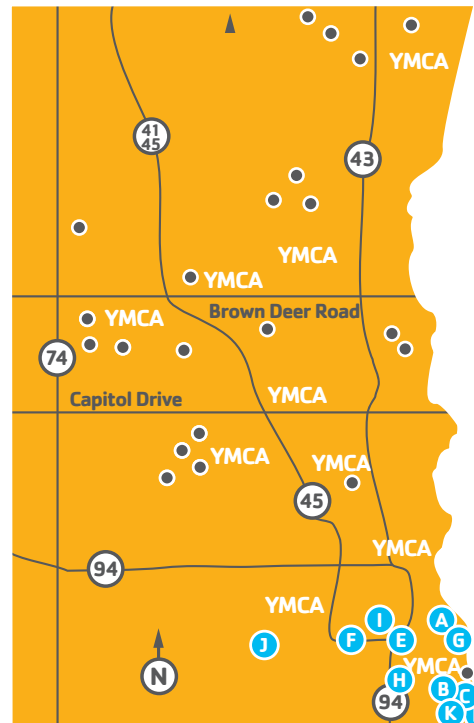
## » FINANCIAL ASSISTANCE

### Bank Draft Authorization Agreement/Credit Card Authorization Agreement
